In pursuance of Essentially Certificate Issued by the Health & Medical Education Department, UT of J&K Government vide No. HD-Drgs/42/2022-02 dated 14.03.2023, permission/approval of Pharmacy Council of India (Regulatory Body) granted vide decision letter dated 28.07.2023 and consequent upon re-inspection of the college conducted on 19.10.2023, by a committee constituted vide order No. No.CDC/2023/2556-65 dated 18.08.2023, the Vice-Chancellor, in anticipation of the approval of the Competent Body, is pleased to grant temporary affiliation in favour of Stephens College of Pharmacy (under the aegis of Dr. Aparna Educational Trust), Nilhalpur, Miran Sahib, Jammu, to start B. Pharmacy Course w.e.f. the academic session 2024-25, with an intake as permitted by the Pharmacy Council of India i.e. 60 seats.

The aforesaid temporary affiliation is subject to the fulfillment of following conditions before the start of class work:

1. The college must appoint the Principal, adequate teaching faculty members and Librarian on regular basis within a period of one month from the date of start of class work as per the prescribed procedure i.e. through proper selection committee as envisaged under the University Statutes. Besides the teaching staff, the college should also appoint supporting staff as prescribed under PCI norms.
2. The college should submit the renewal permission of the Pharmacy Council of India for the session 2024-25 by 10th May, 2024 and also create/deposit the endowment fund as per norms before the start of class work.
